Growing affordable housing

A faith-based client sought to have an organisation providing affordable housing registered as a charity. The Australian Charities and Not-for-profits Commission (ACNC) deemed their eligibility criteria 'too generous', however, and the initial application was rejected.

Understanding when to litigate

Being left out of a will

Our client was left out of her mother's will. Made only a few days before the mother's passing, the will named the client's only sibling as sole beneficiary of an estate.

Moores helped the client understand the circumstances in which the will was made, then assisted in making a family provision claim from the estate.

We proposed a voluntary mediation which yielded a rapid, extremely positive outcome, and avoided lengthy and costly litigation. The client received a large sum and items of great sentimental value, including irreplaceable childhood photos.

GOVERNANCE

Enabling best practice

With new faces on their board and a newly appointed CEO, this public benevolent institution sought to ensure its governing document was up to date. After assessing the document thoroughly, Moores recommended a complete replacement.

We tailored the new document to support best practice governance while also meeting the organisation's unique needs. It incorporated the more flexible provisions now available to registered charities, and appropriate reference to the role of the Australian Charities and Not-for-profits Commission.

NOT-FOR-PROFIT

Providing pro bono support in unprecedented times

Throughout 2020, Moores helped the not-forprofit sector respond to the critical and immense operational changes resulting from the pandemic.

In partnership with Our Community, we first developed a complimentary epidemic-pandemic policy template to help organisations prepare for the onset of COVID-19. As the pandemic progressed, we developed a second template to help organisations protect themselves from the increased risk of ransomware attacks and privacy breaches.

Combined, the templates were downloaded more than 4,000 times.

ELDER LAW

Remedying financial abuse

Moores worked with two siblings concerned their mother's finances were being mismanaged by her attorney. Soon after, their mother passed away, but we continued to act in relation to the deceased estate.

Our investigations uncovered financial and legal documents concerning their late mother's complex affairs. Analysis revealed the attorney had indeed breached their duties in significant and material ways throughout their mother's lifetime.

As a result of our strategic approach and forensic investigation, their late mother's assets were restored. The attorney was held to account and required to return funds to the deceased estate.

WILLS AND ESTATE PLANNING

Using an inheritance to the best advantage

After receiving a \$550,000 inheritance, our client learnt she was no longer entitled to her pension and health care card. Instead of providing for her family in the long-term, the inheritance would now have to pay for life's necessities.

As her son had an intellectual disability, Moores advised that gifting some or all of the inheritance into a Special Disability Trust could prevent the loss of pension. We also showed the trust could pay for many of her son's expenses, freeing up more of his disability support pension.

We prepared the documentation required to establish the trust, and assisted in lodging the paperwork required by Centrelink. We also prepared a will that takes into account the funds gifted into trust, when dividing her estate between her children. TESTIMONIAL: POWER OF ATTORNEY — PROPERTY
